In connection with the dividend payments of \$0.055, \$0.045 and \$0.058 per common share (ex dividend date March 1, 2016) payable on March 1, 2016 to shareholders of record on February 29, 2016 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 26% of such dividend will be a return of capital, 74% ordinary income (including short-term capital gains) and 0% long-term capital gains.
