In connection with the dividend payments of \$0.047, \$0.038 and \$0.050 per common share (ex dividend date May 2, 2016) payable on May 2, 2016 to shareholders of record on April 29, 2016 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 62% of such dividend will be a return of capital, 38% ordinary income (including short-term capital gains) and 0% long-term capital gains.
