In connection with the dividend payments of \$0.047, \$0.038 and \$0.050 per common share (ex dividend date October 3, 2016) payable on October 3, 2016 to shareholders of record on September 30, 2016 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 68% of such dividend will be a return of capital, 32% ordinary income (including short-term capital gains) and 0% long-term capital gains. The amounts and sources of distributions reported in this Section 19 Notice are only estimates and are not being reported for tax reporting purposes.
