In connection with the dividend payments of \$0.0387, \$0.029 and \$0.042 per common share (ex dividend date December 1, 2016) payable on December 1, 2016 to shareholders of record on November 30, 2016 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 44% of such dividend will be a return of capital, 56% ordinary income (including short-term capital gains) and 0% long-term capital gains.
