In connection with the dividend payments of \$0.0387, \$0.029 and \$0.042 per common share (ex dividend date March 1, 2017) payable on March 1, 2017 to shareholders of record on February 28, 2017 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 1% of such dividend will be a return of capital, 99% ordinary income (including short-term capital gains) and 0% long-term capital gains.
