In connection with the dividend payments of \$0.0387 and \$0.042 per common share (ex dividend date March 1, 2019) payable on March 1, 2019 to shareholders of record on February 28, 2019 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 17% of such dividend will be a return of capital, 83% ordinary income (including short-term capital gains) and 0% long-term capital gains.
