Direxion Daily AMZN Bull 2X and Bear 1X Shares

Overview

The <u>Direxion Daily AMZN Bull 2X Shares</u> and Direxion Daily AMZN Bear 1X Shares seek daily investment results, before fees and expenses, of 200% and 100% of the inverse (or opposite), respectively, of the performance of the common shares of Amazon.com, Inc. (NASDAQ: AMZN).

Investing in the funds involves a high degree of risk. Unlike traditional ETFs, or even other leveraged and/or inverse ETFs, these leveraged and/or inverse single-stock ETFs track the price of a single stock rather than an index, eliminating the benefits of diversification. Leveraged and inverse ETFs pursue daily leveraged investment objectives, which means they are riskier than alternatives which do not use leverage. They seek daily goals and should not be expected to track the underlying stock's performance over periods longer than one day. They are not suitable for all investors and should be utilized only by investors who understand leverage risk and who actively manage their investments. The Funds will lose money if the underlying stock's performance is flat, and it is possible that the Bull Fund will lose money even if the underlying stock's performance increases, and the Bear Fund will lose money even if the underlying stock's performance decreases, over a period longer than a single day. Investing in the Funds is not equivalent to investing directly in AMZN.

Single Stock Exposure

Amazon.com, Inc. engages in the retail sale of consumer products and subscriptions in North America and internationally. The company operates through three segments: North America, International, and Amazon Web Services. AMZN is registered under the Securities Exchange Act of 1934, as amended (the "Exchange Act"). *The Net Expense Ratio includes management fees, other operating expenses and Acquired Fund Fees and Expenses. If Acquired Fund Fees and Expenses were excluded, the Net Expense Ratio would be 0.87% for AMZU and 0.95% for AMZD. The Funds' adviser, Rafferty Asset Management, LLC ("Rafferty"), has entered into an Operating Expense Limitation Agreement with each Fund. Under the Operating Expense Limitation Agreement, Rafferty has contractually agreed to waive all or a portion of its management fee and/or reimburse a Fund for Other Expenses through September 1, 2026, to the extent that a Fund's Total Annual Fund Operating Expenses exceed 0.95% of the Fund's average daily net assets (excluding, as applicable, among other expenses, taxes, swap financing and related costs, acquired fund fees and expenses, dividends or interest on short positions, other interest expenses, brokerage commissions and extraordinary expenses). If these expenses were included, the expense ratio would be higher.

The Direxion Daily AMZN Bull 2X Shares (AMZU) seeks 200% daily leveraged investment results and thus will have an increase of volatility relative to the underlying AMZN performance itself. Longer holding periods, higher volatility of AMZN and leverage increase the impact of compounding on an investor's returns. During periods of higher AMZN volatility, the volatility of AMZN may affect the fund's performance.

Important Information Regarding AMZD

The Direxion Daily AMZN Bear 1X Shares (AMZD) seeks daily inverse investment results and is very different from most other exchange-traded funds. Longer holding periods and higher volatility of AMZN increase the impact of compounding on an investor's returns. During periods of higher volatility, the volatility of AMZN may affect the fund's return as much as, or more than, the return of AMZN.

A total loss may occur in a single day. Leverage will also have the effect of magnifying any differences in the Fund's correlation with AMZN and may increase the volatility of the Bull Fund.

Daily Correlation Risk - A number of factors may affect the Bull Fund's ability to achieve a high degree of correlation with AMZN and therefore achieve its daily leveraged investment objective. The Bull Fund's exposure to AMZN is impacted by AMZN's movement. Because of this, it is unlikely that the Bull Fund will be perfectly exposed to AMZN at the end of each day. The possibility of the Bull Fund being materially over- or under-exposed to AMZN increases on days when AMZN is volatile near the close of the trading day.

Daily Inverse Correlation Risk - A number of factors may affect the Bear Fund's ability to achieve a high degree of inverse correlation with AMZN and therefore achieve its daily inverse investment objective. The Bear Fund's exposure to AMZN is impacted by AMZN's movement. Because of this, it is unlikely that the Bear Fund will be perfectly exposed to AMZN at the end of each day. The possibility of the Bear Fund being materially over- or underexposed to AMZN increases on days when AMZN is volatile near the close of the trading day.

Amazon.com, Inc.
