

## Daily MSCI Brazil Bull 2X Shares

## Overview

The Direxion Daily MSCI Brazil Bull 2X Shares seeks daily investment results, before fees and expenses, of 200% of the performance of the MSCI Brazil 25/50 Index. **There is no guarantee that the fund will achieve its stated investment objective.**

This leveraged ETF seeks a return that is 200% of the return of its benchmark index **for a single day. The fund should not be expected to provide two times the return of the benchmark's cumulative return for periods greater than a day.**

## Target Index

The MSCI Brazil 25/50 Index (M1BR2550) is designed to measure the performance of the large- and mid-capitalization segments of the Brazilian equity market, covering approximately 85% of the free float adjusted market capitalization of Brazilian issuers. **One cannot directly invest in an index.**

If these expenses were included, the expense ratio would be higher.
