# Direxion Daily Regional Banks Bull 3X Shares

#### Overview

The <u>Direxion Daily Regional Banks Bull 3X Shares</u> seeks daily investment results, before fees and expenses, of 300% of the performance of the S&P Regional Banks Select Industry Index. There is no guarantee the fund will achieve its stated investment objective.

This leveraged ETF seeks a return that is 300% of the return of its benchmark index for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.

### **Target Index**

The S&P Regional Banks Select Industry Index (SPSIRBKT) is a modified equal-weighted index that is designed to measure performance of the stocks comprising the S&P Total Market Index that are classified in the Global Industry Classification Standard (GICS) regional banks sub-industry. *One cannot invest directly in an Index.* 

Investing in a Direxion Shares ETF may be more volatile than investing in broadly diversified funds. The use of leverage by a Fund increases the risk to the Fund. If these expenses were included, the expense ratio would be higher.
