





# Direxion Monthly NASDAQ-100 Bull 1.25X Fund

#### **Overview**

The <u>Direxion Monthly NASDAQ-100® Bull 1.25X Fund</u> seeks monthly investment results, before fees and expenses, of 125%, of the calendar month performance of the NASDAQ-100® Index. *There is no guarantee that the fund will achieve its stated investment objective.* 

Direxion's Leveraged Index-based Funds seek to provide monthly returns which are a multiple of the returns of the relevant benchmark. In practice, this means that Leveraged Index-based Funds react to gains by increasing market exposure and react to losses by decreasing market exposure.

# **Target Index**

The NASDAQ-100® Index (XNDX) includes 100 of the largest domestic and international non-financial companies listed on the NASDAQ Stock Market® based on market capitalization. All companies listed on the index have an average daily trading volume of at least 200,000 shares. *One cannot invest directly in an index.*

If these expenses were included, the net expense ratio would be higher.
