

## Hilton Tactical Income Fund

In connection with the dividend payments of \$0.0612 and \$0.065 per common share (ex dividend date May 1, 2026) payable on May 1, 2026 to shareholders of record on April 30, 2026 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 29% of such dividend will be a return of capital, 71% ordinary income (including short-term capital gains) and 0% long-term capital gains. The amounts and sources of distributions reported in this Section 19 Notice are only estimates and are not being reported for tax reporting purposes.
