In connection with the dividend payments of \$0.0512 and \$0.055 per common share (ex dividend date August 1, 2024) payable on August 1, 2024 to shareholders of record on July 31, 2024 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 21% of such dividend will be a return of capital, 79% ordinary income (including short-term capital gains) and 0% long-term capital gains.
