In connection with the dividend payments of \$0.0387 and \$0.042 per common share (ex dividend date February 1, 2019) payable on February 1, 2019 to shareholders of record on January 31, 2019 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 46% of such dividend will be a return of capital, 54% ordinary income (including short-term capital gains) and 0% long-term capital gains.
