In connection with the dividend payments of \$0.0425 and \$0.046 per common share (ex dividend date February 1, 2024) payable on February 1, 2024 to shareholders of record on January 31, 2024 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 31% of such dividend will be a return of capital, 69% ordinary income (including short-term capital gains) and 0% long-term capital gains.
