In connection with the dividend payments of \$0.0612 and \$0.065 per common share (ex dividend date July 1, 2026) payable on July 1, 2026 to shareholders of record on June 30, 2026 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 6% of such dividend will be a return of capital, 94% ordinary income (including short-term capital gains) and 0% long-term capital gains.
