In connection with the dividend payments of \$0.0483 and \$0.052 per common share (ex dividend date May 1, 2024) payable on May 1, 2024 to shareholders of record on April 30, 2024 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 25% of such dividend will be a return of capital, 75% ordinary income (including short-term capital gains) and 0% long-term capital gains.
