In connection with the dividend payments of \$0.0512 and \$0.055 per common share (ex dividend date October 1, 2024) payable on October 1, 2024 to shareholders of record on September 30, 2024 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 99% of such dividend will be a return of capital, 1% ordinary income (including short-term capital gains) and 0% long-term capital gains. The amounts and sources of distributions reported in this Section 19 Notice are only estimates and are not being reported for tax reporting purposes.
