

### Direxion Daily Mid Cap Bull 3X Shares

#### Overview

The Direxion Daily Mid Cap Bull 3X Shares seeks daily investment results, before fees and expenses, of 300% of the performance of the S&P Mid Cap 400® Index. **There is no guarantee the fund will achieve its stated investment objective.**

This leveraged ETF seeks a return that is 300% of the return of its benchmark index **for a single day. The fund should not be expected to provide three times the return of its benchmark's cumulative return for periods greater than a day.**

#### Target Index

The S&P Mid Cap 400® Index (SPTRMDCP) is a float-adjusted market capitalization weighted index that measures the performance of 400 mid-sized companies in the United States. **One cannot invest directly in an index.**
