Overview

The Direxion [Daily Magnificent 7 Bull 2X and Bear 1X Shares](#) seek daily investment results, before fees and expenses, of 200%, or 100% of the inverse (or opposite), of the performance of the Indxx Magnificent 7 Index. **There is no guarantee the funds will achieve their stated investment objectives.**

These leveraged ETFs seek a return that is 200% or -100% the return of its benchmark index **for a single day. The funds should not be expected to provide two times or negative one times the return of the benchmark's cumulative return for periods greater than a day.**

Target Index

The Indxx Magnificent 7 Index (IFOTQ) is provided by Indxx and is designed to track the performance of seven of the leading NASDAQ listed companies. **One cannot invest directly in an index.**

Investing in a Direxion Shares ETF may be more volatile than investing in broadly diversified funds. The use of leverage by a Fund increases the risk to the Fund. Under the Operating Expense Limitation Agreement, Rafferty has contractually agreed to waive all or a portion of its management fee and/or reimburse a Fund for Other Expenses through September 1, 2026, to the extent that a Fund's Total Annual Fund Operating Expenses exceed 0.95% for QQQU and 0.45% for QQQD of the Fund's average daily net assets (excluding, as applicable, among other expenses, taxes, swap financing and related costs, acquired fund fees and expenses, dividends or interest on short positions, other interest expenses, brokerage commissions and extraordinary expenses). If these expenses were included, the expense ratio would be higher.*

The possibility of the Bear Fund being materially over- or under-exposed to the Index increases on days when the Index is volatile near the close of the trading day.
