Overview

The [Direxion Daily S&P 500 Bear 1X Shares](#) seeks daily investment results, before fees and expenses, of 100% of the inverse (or opposite) of the performance of the S&P 500® Index. **There is no guarantee the fund will meet its stated investment objectives.**

This ETF seeks a return that is -100% of the return of its benchmark index **for a single day**. **The fund should not be expected to provide 100% of the inverse of the benchmark's cumulative Acquired Fund Fees and return for periods greater than a day.**

Target Index

The S&P 500® Index (SPXT) is designed to be comprised of stocks that are the 500 leading, large-cap U.S. listed issuers. The securities are selected on the basis of market capitalization, financial viability of the company, sector representation, public float, liquidity and price of a company's shares outstanding. The Index is a float-adjusted, market capitalization-weighted index. **One cannot directly invest in an index.**

Investing in a Direxion Shares ETF may be more volatile than investing in broadly diversified funds. The use of leverage by a Fund increases the risk to the Fund. If these expenses were included, the expense ratio would be higher.*
