Overview

The <u>Direxion Daily Utilities Bull 3X Shares</u> seeks daily investment results, before fees and expenses, of 300% of the performance of the Utilities Select Sector Index. **There is no guarantee the fund will achieve its stated investment objective.**

This leveraged ETF seeks a return that is 300% of the return of its benchmark index for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.

Target Index

The Utilities Select Sector Index (IXUTR) is provided by S&P Dow Jones Indices and includes domestic companies from the utilities sector which includes the following industries: electric utilities; multi-utilities; water utilities; independent power producers and energy trades; and gas utilities. *One cannot invest directly in an index.*

Investing in a Direxion Shares ETF may be more volatile than investing in broadly diversified funds. The use of leverage by a Fund increases the risk to the Fund. If these expenses were included, the expense ratio would be higher.
