# Daily S&P 500 Bull and Bear 3X Shares

#### **Overview**

The Direxion Daily S&P 500<sup>®</sup> Bull and Bear 3X Shares seeks daily investment results, before fees and expenses, of 300%, or 300% of the inverse (or opposite), of the performance of the S&P 500<sup>®</sup> Index. There is no guarantee the funds will meet their stated investment objectives.

These leveraged ETFs seek a return that is 300% or -300% of the return of their benchmark index *for a single day*. The funds should not be expected to provide three times or negative three times the return of the benchmark's cumulative return for periods greater than a day.

## **Target Index**

Standard & Poor's® selects the stocks comprising the S&P 500® Index (SPXT) on the basis of market capitalization, financial viability of the company and the public float, liquidity and price of a company's shares outstanding. The Index is a float-adjusted, market capitalization-weighted index. *One cannot directly invest in an index*.
