Overview


The <u>Direxion Hydrogen ETF</u> offers exposure to 30 companies leading the way towards net-zero emissions by providing more accessible, efficient, sustainable solutions across the following five hydrogen-related subthemes. HJEN may be considered a satellite holding to complement other broader positions within a portfolio.

- Hydrogen Production and Generation: Companies involved in the process of hydrogen generation, in either liquid or solid form.
- 2) Hydrogen Storage and Supply: Companies engaged in providing storage and transportation services of hydrogen. It also includes companies that supply hydrogen to various users and operate hydrogen fueling stations across countries.
- **3) Fuel Cell and Battery**: Companies manufacturing fuel cells and batteries that are run on hydrogen-based technology.
- **4) Hydrogen Systems and Solutions**: Companies offering equipment, components or technology used in hydrogen industry. Those involved in providing solutions and systems to the value chain across hydrogen generation, storage and supply.
- 5) Membrane and Catalyst: Companies that design and produce membrane, filters, catalyst or membrane assemblies for fuel cell, or hydrogen-related, technologies.

Investment Objective

The Direxion Hydrogen ETF seeks investment results, before fees and expenses, that track the Indxx Hydrogen Economy Index. *There is no guarantee that the fund will achieve its stated investment objective.*

Index Description

The Index tracks the performance of companies that provide goods and/or services related to the hydrogen industry, including hydrogen generation and storage, transportation and supply of hydrogen, fuel cells, and hydrogen fueling stations. The Index includes domestic securities as well as securities listed on various developed and emerging markets, excluding India and Vietnam. The Index will be reconstituted annually and rebalanced quarterly. *One cannot invest directly in an index.*
