

## Direxion Hilton Tactical Income Fund

In connection with the dividend payments of \$0.0376 and \$0.041 per common share (ex dividend date October 3, 2022) payable on October 3, 2022 to shareholders of record on September 30, 2022 of the Investor Class and Institutional Class shares, respectively, it is anticipated that 17% of such dividend will be a return of capital, 83% ordinary income (including short-term capital gains) and 0% long-term capital gains.
